A personal data processing means any of the following actions: data collecting, data recording, data systematizing, data accumulating, data storing, data modifying (data updating), data extracting, data distributing (data transmitting), data disseminating, data publishing, anonymizing data, blocking data, disclosing data, deleting data and destroying data.
2. The list of my personal data in respect of which I give my informed consent to the Operator to process:

  - Health information;

On the basis of the written request the Operator stops processing the undersigned's personal data and the personal data shall be destroyed if there is no legal reason to do otherwise.
