**Technical regulations  
for the International Olympiad for schoolchildren “Tuymaada” in physics in 2023**

**1. General provisions**

1.1. Technical regulations for Tuymaada Olympiad for schoolchildren in 2023 (hereinafter referred to as Olympiad Regulations) have been developed under Provisions on the Tuymaada International School Olympiad (hereinafter referred to as Olympiad Provisions).

1.2. In 2023, the Olympiad in Physics will be held in full-time format.

1.3. The start and end times of the Olympiad events are indicated according to the local time in Olympiad Regulations and in Olympiad program posted on the Olympiad official website.

**2. Registration**

2.1 The participant of the Olympiad must become familiar with Olympiad Provisions, Olympiad Regulations and Olympiad program and register within the terms indicated on the official Olympiad website.

2.2. In case of providing false personal data during registration, the participant may not be allowed to participate in the Olympiad.

**3. Olympiad**

3.1. Physics Olympiad will contain one theoretical round and one experimental round, each lasting 5 hours.

3.2. The participant is allowed to write the tour only with a possession of the passport or another identification document with photo.

3.3. A participant may have writing utensils, a ruler, non-programmable calculator. During the Olympiad it is not allowed to use mobile phones and other electronic means of communication and data processing.

3.4. Participants will be offered theoretical tasks, each full solution is estimated up to 10 points, and experimental tasks, each full solution of which is estimated up to 15 points. The conditions of the tasks will be prepared by the Olympiad methodological committee in Russian and, with the participation of foreign participants, in English. The methodical commission is fully responsible for the correctness of conditions in Russian and English.

3.5. The jury guarantees to answer the participants' questions not earlier than 30 minutes after and will finish answering questions 30 minutes before the end of the round.

3.6. All schoolchildren who have completed not more than 9 years of secondary education are allowed to participate in the junior league. All schoolchildren applying for the Senior League are allowed to participate.

3.7. The program of the Senior League Olympiad is similar to the eleventh grade All-Russian Olympiad with International Physical Olympiad elements. The program in the junior league corresponds to the program of the first nine years of secondary schools in Russia.

3.8. If statements that are not part of the program are used, these claims must be accurately formulated and fully proven by participant.

3.9. The work must be prepared in Russian or English (for foreign participants).

3.10. At the end of the round, the participant must hand in his work.

3.11. The participant can hand in the work ahead of schedule, after which he must immediately leave the place of the tour.

3.12. After collecting the works of all participants, the Proctor sends the works to the organizing committee for encryption of works.

3.13. After the Olympiad, participants can receive a methodological manual with solutions and approximate evaluation criteria in electronic form.

3.14. Draft is not checked.

3.15. After the end of the check, organizing committee representatives decode the work and post the preliminary protocols on the official website of the Olympiad.

3.16. Before the appeal, the jury announces the test criteria, which are not subject to change on appeal.

#### **4. Appeal**

4.1. Before the appeal, the jury members familiarize the participants of the Olympiad with the solutions and criteria for evaluating problems or provide a handbook with solutions and evaluation criteria in English and Russian in electronic form.

4.2. Participants may submit an appeal to the jury. Applications are accepted only until the announced hour of the appeal and on special forms that participants can receive at the place of the appeal.

4.3. Criteria for evaluating tasks are not subject to appeal.

4.4. At the appeal, the text of the solution of the problem is re-checked, and the oral explanations of the participant during the appeal are not evaluated.

4.6. During the appeal, the evaluation of the problem under discussion can be changed in any direction.

4.7. If the participant does not agree with the evaluation after the appeal, then the issue is considered again in the presence of the chair of the jury. The decision of the President of the Jury is final.

***In case of violation of the rules, the participant may be disqualified by the decision of the jury.***
